WHAT IS THE “ELECTRONIC SIGNATURE”?

A **simple** and **legally acceptable** means to validate and sign a digital document.

It is an excellent **way to speed up the document signing process**.

FULL COMPLIANCE WITH THE INTERNATIONAL, EUROPEAN AND FRENCH LAWS

- For France, Articles 1366 and 1367 of the French Civil Code clarify its scope.
- For Europe, following the EU directive of 13 December 1999, the European regulation of 23 July 2014 “eIDAS” has become effective in France on 1 July 2016.
- Beyond that, the laws of certain countries are generally based on the UNCITRAL Model Law (United Nations Commission on International Trade Law). In other words, it is the contract that defines its applicable law as regards electronic signatures, depending on the elected law.

REQUIREMENTS FOR ELECTRONIC SIGNATURE

- A **prior approval** of all signatories to implement this electronic process.
- **Authentication of the participants’ identity**
- A **workflow** detailing each stage of the signing process
- An **automated process** enabling the tracking of the stages and the storage of the signed documents in a secure repository.

A SIMPLIFIED AND SMOOTH PROCESS

SATT Ouest Valorisation chose a **trusted third party** complying to the **eIDAS** certification and certified by **ANSSI** for the authentication.

This process requires:

- **A secured web application hosted in France**, used to
 - Collect the signatures of the document for which each contact is invited by email to validate or sign the document;
 - Manage the process in real time, allowing all participants to follow the process and download the document after it has been signed.
- **A dedicated task for each person involved** in the two roles of the process:
 - One or more validators: as the document reader, they approve the document but do not sign it;
 - The signatory, as the legal representative, receives the validation code by telephone - SMS or voice code - in order to electronically sign the document.
- The necessary **authentication**, complying with GDPR requirements:
 - An email address for each validator;
 - An email address and telephone number (mobile or land line) for each signatory.
